#### **Product Description**

Recombinant full-length human p110 $\alpha$  (E545K) mutant subunit and human p85 $\alpha$  wild-type subunit were coexpressed by baculovirus in Sf9 insect cells using an N-terminal His tag on both proteins. The p110 $\alpha$  gene accession number is NM 006218; p85 $\alpha$  is NM 181523.

#### **Formulation**

Recombinant protein stored in 50mM sodium phosphate, pH 7.0, 300mM NaCl, 150mM imidazole, 0.1mM PMSF, 0.25mM DTT, 25% glycerol.

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.


#### **Scientific Background**

The PI3K comprises of a 110 kDa catalytic subunit and a 85 kDa regulatory subunit. A number of isoforms of the 110 kDa catalytic subunit and the 85 kDa regulatory subunit exist in cells. The p110 $\alpha$  catalytic subunit (PIK3CA) is frequently mutated or amplified in a variety of cancers including ovarian and colon and this protein is one of the PI3K mutants (1). PIK3CA gene copy number is increased in over 30% of ovarian cancers and this leads to increased PI3-kinase activity. Furthermore, the activity of p110 $\alpha$  is essential for vascular development and inactivation of p110 $\alpha$  leads to severe defects in angiogenic sprouting and vascular remodeling (2).



The specific activity of PI3K (p110 $\alpha$ (E545K)/p85 $\alpha$ ) was determined to be **7,576 nmol/min/mg** as per activity assay protocol.

# **Activity Assay Protocol**

#### **Reaction Components**

#### Active Kinase (Catalog #: P27-152H)

Active PI3K (E545K)  $(0.05\mu g/\mu l)$  diluted with 1x Lipid Kinase Buffer (Catalog #: L01-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active PI3K (E545K) for optimal results).

#### **Lipid Kinase Buffer (5x)** (Catalog #: L01-09)

250 mM HEPES pH 7.5, 250 mM NaCl, 10 mM MgCl $_2$ , 2.5 mM EGTA,  $125 \mu g/mL$  BSA and 0.2% Triton X-100. Dilute to 1x and add 0.05 mM fresh DTT prior to use.

#### Lipid Dilution Buffer (1x) (Catalog #: L21-09)

25mM HEPES pH 7.5 and 0.5mM EGTA.

# ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo™ Reagent Kinase Detection Reagent

#### 1M MgCl<sub>2</sub> Solution - Required for ADP-Glo reaction

#### 250 μM ATP Assay Solution

Prepare the ATP assay solution by diluting ATP solution, 10 mM (Promega, Cat # V9101) to 250  $\mu$ M in 1x Lipid Assay Buffer (prepared from Lipid Kinase Buffer 5x; Catalog #: L01-09).

#### Substrate (Catalog #: P429-59)

PI(4,5)P2:PS substrate solution contains  $125\mu M$  of PI(4,5)P2 and  $1000\mu M$  of PS in 1x Lipid Dilution Buffer.

#### **Assay Protocol**

The PI3K assay is performed using the ADP-Glo™ Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the PI3K reaction. The ADP- Glo™ Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active PI3K, Lipid Kinase Buffer, Substrate and Lipid Dilution Buffer on ice.
- Step 2. In a pre-cooled 96-well opaque plate, add the following reaction components bringing the initial reaction volume up to 20µl:

Component 1. 10μl of diluted Active Pl3K(Catalog #P27-152H)

Component 2. 5µl of PI(4,5)P2:PS substrate (sonicate for 1 minute prior to use)

Component 3. 5µl 1x Lipid Kinase Buffer

- **Step 3.** Set up the blank control as outlined in step 3, excluding the addition of the substrate. Replace the substrate with an equal volume of Lipid Dilution Buffer.
- Step 4. Initiate the reaction by the addition of  $5\mu$ l of  $250\,\mu$ M ATP Assay Solution thereby bringing the final volume up to  $25\mu$ l. Shake the reaction mixture in the 96-well opaque plate for 2 minutes and continue the incubation at  $30^{\circ}$ C for 40 minutes.
- Step 5. After the 40 minute incubation period, terminate the reaction and deplete the remaining ATP by adding 25µl of ADP-Glo™ Reagent with 10mM MgCl₂. Shake the 96-well plate and then incubate the reaction mixture for another 40 minutes at ambient temperature.
- **Step 6.** Then add 50µl of the Kinase Detection Reagent to the 96-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 7. Read the 96-well reaction plate using the KinaseGlo Luminescence Protocol on a GloMax plate reader (Promega; Cat# E7031).
- **Step 8.** Determine the corrected activity (RLU) by removing the blank control value (see Step 3) for each sample and calculate the kinase specific activity as outlined below.
