Product Description

Recombinant full-length human GSK3B was expressed by baculovirus in Sf9 insect cells using an N-terminal His tag. The gene accession number is NM_001146156.

Formulation

Recombinant protein stored in 50mM sodium phosphate, pH 7.0, 300mM NaCl, 150mM imidazole, 0.1mM PMSF, 0.25mM DTT, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background

GSK3B is a serine threonine protein kinase that was originally identified as the kinase that phosphorylates and inhibits glycogen synthase (1). GSK3ß is ubiquitously present in human tissues and implicated in the regulation of several physiological processes, including the control of glycogen and protein synthesis by insulin, modulation of the transcription factors AP-1 and CREB. Transient transfection of human GSK3B into Chinese hamster ovary cells stably transfected with individual human tau isoforms leads to hyperphosphorylation of tau at all the sites investigated with phosphorylation-dependent anti-tau antibodies (2).





The specific activity of GSK3B was determined to be 638 nmol /min/mg as per activity assay protocol, and was equivalent to 186 nmol/min/mg as per radiometric assay.

Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: G09-10H)

Active GSK3 β (0.1 μ g/ μ l) diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active GSK3 β for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200 mM Tris-HCl, pH 7.4, 100 mM MgCl₂ and 0.5 mg/ml BSA. Add fresh DTT prior to use to a final concentration of $250 \mu M$.

Kinase Dilution Buffer IX (1x) (Catalog #: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled H_2O . Add fresh DTT prior to use to a final concentration of $50\mu M$.

ADP-Glo™ Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-Glo™ Reagent Kinase Detection Reagent

Substrate (Catalog #: G50-58)

GSK3 substrate (YRRAAVPPSPSLSRHSSPHQ(pS)EDEEE) diluted in distilled H_2O to a final concentration of 1mg/ml.

Assay Protocol

The GSK3β assay is performed using the ADP-GloTM Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the Active GSK3β reaction. The ADP- GloTM Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active GSK3β, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15μL enzyme dilution using Kinase Dilution Buffer IX (1x), at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

- Step 3. Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5μL:
 - Component 1. 3µl of diluted Active GSK3β (G09-10H).
 - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- **Step 7.** Then add 10μ l of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
