# **Product Description**

Full-length recombinant human MASTL was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number for MASTL is <a href="MASTL">NM 001172303</a>.

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, and 25% glycerol.

#### Storage and Stability


Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

### **Scientific Background**

Microtubule associated serine/threonine kinase-like (MASTL) belongs to the MAST family, AGC Ser/Thr protein kinase group. MASTL promotes mitotic progression and cell cycle reentry after DNA damage. Loss of MASTL leads to defects in chromosome condensation, separation, and other aspects of mitotic progression, which is primarily mediated by inhibiting PP2A/B558. Overexpression of MASTL is correlated with cancer progression, poor patient survival, and tumor recurrence in various cancers.
