Product Description

Recombinant human BCR-RET, the fusion protein [BCR (1-426)-RET (713-end)], was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The BCR gene accession number is $\underline{BC066122}$ and RET's one is \underline{NM} 020630.

Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background

BCR-RET is a chimeric fusion of BCR and RET genes generated by a balanced translocation of genes from t(10;22)(q11;q11) and this leads to aberrant activation of RET activity which can transform hematopoietic cells and skew the hematopoietic differentiation program towards the monocytic/macrophage lineage (1). The BCR-RET fusion is frequently found in chronic myelomonocytic leukemia (CMML) cases. The RET fusion genes seem to constitutively mimic the same signaling pathway as RAS mutations frequently involved in CMML.





Specific Activity



The specific activity of BCR-RET was determined to be **59 nmol** /min/mg as per activity assay protocol and was equivalent to **104 nmol/min/mg** as per radiometric assay.

Purity



The purity of BCR-RET was determined to be >80% by densitometry.

Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: R02-19EG)

Active BCR-RET ($0.1\mu g/\mu l$) diluted with Kinase Dilution Buffer IX (1x) (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of active BCR-RET for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl₂ and 0.5mg/ml BSA. Add fresh DTI prior to use to a final concentration of 250μ M.

Kinase Dilution Buffer IX (1x) (Catalog #: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold water. Add fresh DTT to the aliquot prior to use to a final concentration of $50\mu M$.

ADP-Glo[™] Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo™ Reagent Kinase Detection Reagent

Substrate (Catalog #: I15-58)

IGF1Rtide synthetic peptide substrate (KKKSPGEYVNIEFG) diluted in distilled H2O to a final concentration of 1mg/ml.

Assay Protocol

The BCR-RET assay is performed using the ADP-Glo™ Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the BCR-RET reaction. The ADP- Glo™ Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active BCR-RET, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15 μL enzyme dilution at the desired concentration, with Kinase Dilution Buffer IX (1x), in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25 μM example):

- Step 3. Transfer the following reaction components prepared in Step 2 to a 384-well opaque plate bringing the reaction volume up to $5\mu L$:
 - Component 1. 3µl of diluted Active BCR-RET (Catalog # R02-19EG).
 - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- **Step 4.** Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- **Step 5**. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5μl of ADP-GloTM Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10μ l of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
