Product Description

Recombinant human EGFR (d746-750 T790M L858R) (668end) was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM 005228.

Formulation

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background


EGFR is the receptor for members of the EGF family and is a transmembrane glycoprotein that has tyrosine kinase activity. Binding of epidermal growth factor to EGFR induces receptor dimerization and tvrosine autophosphorylation and leads to cell proliferation, differentiation, motility, and cell survival (1). Activation of EGFR triggers mitogenic signaling in gastrointestinal mucosa, and its expression is upregulated in colon cancers and most neoplasms (2). Activation of EGFR triggers activation of the ERK-signaling pathway in normal gastric epithelial and colon cancer cell lines. Inactivation of EGFR with selective inhibitors significantly reduces ERK2 activation, c-fos mRNA expression and cell proliferation.



Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: E10-122XG)

Active EGFR (d746-750 T790M L858R) ($0.1 \mu g/\mu l$) diluted with Kinase Dilution Buffer X (Catalog #: K20-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active EGFR (d746-750 T790M L858R) for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl₂ and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of 250μ M.

Kinase Dilution Buffer X (1x) (Catalog #: K20-09)

Buffer components: 40mM Tris-HCl, pH 7.4, 20mM MgCl₂, 2.5 mM MnCl₂ and 0.1mg/mL BSA. Add fresh DTT prior to use to a final concentration of 50μ M.

ADP-Glo[™] Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-GloTM Reagent Kinase Detection Reagent

Substrate (Catalog #: P61-58)

Poly (4:1 Glu, Tyr) synthetic peptide substrate diluted in 25mM Tris-HCl solution (pH 7.5) to a final concentration of 1mg/ml.

Cofactor (Catalog #: M40-09-25)

Diluted in distilled H₂O to a working concentration of 1M.

Assay Protocol

The EGFR (d746-750 T790M L858R) assay is performed using the ADP-GloTM Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the EGFR (d746-750 T790M L858R) reaction. The ADP- GloTM Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

Step 1. Thaw the Active EGFR (d746-750 T790M L858R), Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15μL enzyme dilution with Kinase Dilution Buffer X at the desired concentration, in a pre-chilled 96-well plate.

Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

Component	Amount (µL)	Component	Amount (µL)
10mM ATP Solution	1	Substrate at 1mg/mL	80
Kinase Assay Buffer III (5x)	78	1 M MnCl ₂	1

Step 3. Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5μ L:

Component 1. 3µl of diluted Active EGFR (d746-750 T790M L858R) (Catalog #E10-122XG)

- **Component 2.** 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer X.
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10μl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- Step 9. Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
