
Scientific Background

FLT3 is a receptor tyrosine kinase that has been shown to play a role in proliferation and survival of hematopoietic progenitor cells as well as differentiation of early B lymphoid progenitors (1). FLT3 consists of an extracellular domain composed of five immunoglobulin-like domains, one transmembrane region, and a cytoplasmic kinase domain split into two parts by a kinase-insert domain. FLT3 is the most frequently mutated gene in cases of acute myelogenous leukemia (AML). About 30% to 35% of patients have either internal tandem duplications (ITDs) in the juxtamembrane domain or mutations in the activating loop of FLT3 (2). The consequence of either FLT3-ITD or activating loop mutations is the constitutive activation of the tyrosine kinase activity.



Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: F12-12KG)

Active FLT3 (F691L D835Y) ($0.05\mu g/\mu l$) diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active FLT3 (F691L D835Y) for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl₂ and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of 250μ M.

Kinase Dilution Buffer IX (1x) (Catalog #: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled H_2O . Add fresh DTT prior to use to a final concentration of $50\mu M$.

ADP-Glo[™] Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10 mM ADP solution, 10 mM ADP-Glo™ Reagent Kinase Detection Reagent

Substrate (Catalog #: A02-58)

Abltide synthetic peptide substrate (EAIYAAPFAKKK) diluted in distilled H₂O to a final concentration of 1mg/ml.

Assay Protocol

The FLT3 (F691L D835Y) assay is performed using the ADP-GloTM Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the FLT3 (F691L D835Y) reaction. The ADP- GloTM Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active FLT3 (F691L D835Y), Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15μL enzyme dilution using Kinase Dilution Buffer IX (1x), at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25μM ATP example):

- **Step 3.** Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5μ L:
 - Component 1. 3µl of diluted Active FLT3 (F691L D835Y) (Catalog # F12-12KG).
 - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- Step 4. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- **Step 5**. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- **Step 7.** Then add 10μ l of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
