Product Description

Recombinant 2019-nCoV Spike protein \$1 (16-685) was expressed in CHO cells using a C-terminal His tag. The gene accession number is MN908947.

Recombinant protein stored in 50mM sodium phosphate, pH 7.5, 300mM NaCl, 150mM imidazole.

Storage and Stability

Aliquot protein into smaller quantities after centrifugation and store at –70°C. Avoid repeated handling and multiple freeze/thaw cycles.


Scientific Background

The severe acute respiratory syndrome related novel coronavirus SARS-CoV-2 has caused the pandemic of respiratory diseases (COVID-19) around the world in 2020 (1). The spike glycoprotein (S) of coronavirus belongs to the type I transmembrane protein containing two subunits, S1 and S2 (2), which is also known to be the key component to bind with host cells through the interaction with angiotensin-converting enzyme 2 (ACE2) (3). A receptor binding domain (RBD) of S1 can recognize the cell surface receptor and the mutation of RBD could cause higher mortality rate (3).







SDS-PAGE gel image

The purity of 2019-nCoV Spike protein S1 was determined to be >90% by densitometry.
Observed MW ~125 kDa.
Calculated MW 76.4 kDa.

Binding of ACE2 (19-740) Protein (A51C2-G341F) to immobilized 2019-nCoV spike protein \$1 (C19\$1-G241H) was determined by functional ELISA.



FACS assay showed 2019-nCoV Spike protein \$1 can bind to ACE2 overexpressing cells. ACE2 overexpressing cells were stained with 2019-nCoV Spike protein \$1, followed by anti-2019CoV Spike Protein antibody (C19\$1-61H) and fluorescence-conjugated secondary antibody.
