
Scientific Background

Fibroblast growth factor receptor 3 (FGFR3) is part of a family of fibroblast growth factor receptors that share similar structure and function. FGFR3 plays a role in several important cellular processes, including regulation of cell growth and division, determination of cell fate, formation of blood vessels, wound healing and embryo development (1). FGFR3 is involved in the development and maintenance of bone and brain tissue. Mutations in FGFR3 have been implicated in causing bladder cancer, cancer of white blood cells (multiple myeloma) and cervical cancer (2).



Activity Assay Protocol

Reaction Components

Active Kinase (Catalog #: F06-12GG)

Active FGFR3 (V555M) (0.1 μ g/ μ l) diluted with Kinase Dilution Buffer X (Catalog #: K20-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active FGFR3 (V555M) for optimal results).

Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl₂ and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of 250μ M.

Kinase Dilution Buffer X (Catalog #: K20-09)

Buffer components: 40mM Tris-HCl, pH 7.4, 20mM MgCl₂, 2.5 mM MnCl₂ and 0.1 mg/mL BSA. Add fresh DTT prior to use to a final concentration of 50μ M.

Assay Protocol

The FGFR3 (V555M) assay is performed using the ADP-Glo™ Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the FGFR3 (V555M) reaction. The ADP-Glo™ Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using Juciferase/Juciferin reaction.

- **Step 1.** Thaw the Active FGFR3 (V555M), Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15µL enzyme dilution with Kinase Dilution Buffer X at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

- Step 3. Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to $5\mu L$:
 - Component 1. 3µl of diluted Active FGFR3 (V555M) (Catalog #F06-12GG).
 - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- **Step 4.** Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer X.
- **Step 5.** Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10µl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- Step 8. Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
