### **Product Description**

Recombinant full-length human PKAc $\alpha$  was expressed by baculovirus in Sf9 insect cells using an N-terminal GST tag. The gene accession number is NM 002730.

#### **Formulation**

Recombinant protein stored in 50mM Tris-HCl, pH 7.5, 150mM NaCl, 10mM glutathione, 0.1mM EDTA, 0.25mM DTT, 0.1mM PMSF, 25% glycerol.

#### Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

#### **Scientific Background**

The catalytic subunit C-alpha of PKA (PKAc $\alpha$ ) is a member of the Ser/Thr protein kinase family and has been assigned to chromosome region 19p13.1 (1). Null mutation in PKAc $\alpha$  leads to early postnatal lethality in the majority of C-alpha knockout mice. Surprisingly, a small percentage of C-alpha knockout mice, although runted, survived to adulthood. In these animals, compensatory increases in C-beta levels occurred in brain whereas many tissues, including skeletal muscle, heart, and sperm, contained less than 10% of the normal PKA activity (2).



# **Activity Assay Protocol**

#### **Reaction Components**

#### Active Kinase (Catalog #: P51-10G)

Active PKAc $\alpha$  (0.1 $\mu$ g/ $\mu$ l) diluted with Kinase Dilution Buffer IX (Catalog #: K29-09) and assayed as outlined in sample activity plot. (Note: these are suggested working dilutions and it is recommended that the researcher perform a serial dilution of Active PKAc $\alpha$  for optimal results).

### Kinase Assay Buffer III (5x) (Catalog #: K03-09)

Buffer components: 200mM Tris-HCl, pH 7.4, 100mM MgCl $_2$  and 0.5mg/ml BSA. Add fresh DTT prior to use to a final concentration of 250 $\mu$ M.

### Kinase Dilution Buffer IX (1x) (Catalog #: K29-09)

Kinase Assay Buffer III (Catalog #: K03-09) diluted at a 1:4 ratio (5X dilution) with cold, distilled  $H_2O$ . Add fresh DTT prior to use to a final concentration of  $50\mu M$ .

#### ADP-Glo<sup>™</sup> Kinase Assay Kit (Promega, Cat # V9101)

ATP solution, 10mM ADP solution, 10mM ADP-Glo™ Reagent Kinase Detection Reagent

#### Substrate (Catalog #: C50-58)

CREBtide synthetic peptide substrate (KRREILSRRPSYR) diluted in 20mM Tris-HCl, pH 7.5, solution to a final concentration of 1mg/ml.

#### **Assay Protocol**

The PKAc $\alpha$  assay is performed using the ADP-Glo<sup>TM</sup> Kinase Assay kit (Promega; Cat# V9101) which quantifies the amount of ADP produced by the PKAc $\alpha$  reaction. The ADP- Glo<sup>TM</sup> Reagent is added to terminate the kinase reaction and to deplete the remaining ATP, and then the Kinase Detection Reagent is added to convert ADP to ATP and to measure the newly synthesized ATP using luciferase/luciferin reaction.

- Step 1. Thaw the Active PKAcα, Kinase Assay Buffer III (5x), and Substrate on ice. Prepare a 15μL enzyme dilution using Kinase Dilution Buffer IX (1x), at the desired concentration, in a pre-chilled 96-well plate.
- Step 2. Prepare a substrate/ATP mixture as follows (25µM ATP example):

- Step 3. Transfer the following reaction components prepared in Steps 1 and 2 to a 384-well opaque plate, bringing the reaction volume up to 5µL:
  - **Component 1.** 3μl of diluted Active PKAcα (Catalog #P51-10G)
  - Component 2. 2µl of Substrate/ATP mix as prepared in the table above. This initiates the reaction.
- **Step 4**. Set up the blank control as outlined in step 2, excluding the addition of the kinase. Replace the kinase with an equal volume of Kinase Dilution Buffer IX (1x).
- Step 5. Incubate at ambient temperature for 40 minutes.
- Step 6. After the 40-minute incubation period, terminate the reaction and deplete the remaining ATP by adding 5µl of ADP-Glo™ Reagent. Spin down and shake the 384-well plate. Then incubate the reaction mixture for another 40 minutes at ambient temperature.
- Step 7. Then add 10µl of the Kinase Detection Reagent to the 384-well plate and incubate the reaction mixture for another 30 minutes at ambient temperature.
- **Step 8.** Read the 384-well reaction plate using the Luminescence Module Protocol on a GloMax®-Multi Microplate Multimode Reader (Promega; Cat# E7061).
- **Step 9.** Determine the corrected activity (RLU) by removing the blank control value (see Step 4) for each sample and calculate the kinase specific activity as outlined below.
