Product Description

Recombinant full-length human Alpha-synuclein was expressed in E. coli cells using an N-terminal His tag and was phosphorylated by co-expression with PLK2 *in vivo*. The gene accession number is <u>NM 000345</u>.

Formulation

Recombinant protein stored in 50mM sodium phosphate, pH 7.5, 300mM NaCl, 150mM imidazole, 0.25mM DTT, 25% glycerol.

Storage and Stability

Store product at -70°C. For optimal storage, aliquot target into smaller quantities after centrifugation and store at recommended temperature. For most favorable performance, avoid repeated handling and multiple freeze/thaw cycles.

Scientific Background

Alpha-synuclein is a member of the synuclein family which also includes beta- and gamma-synuclein. These proteins are abundantly expressed in the brain and alpha- and beta-synuclein selectively inhibit phospholipase D2 which is a highly conserved protein that is also abundant in neurons, especially presynaptic terminals (1). Alphasynuclein gene is not a major risk factor in familial Parkinson disease (2). Alpha-synuclein may serve to integrate presynaptic signaling and membrane trafficking and Alphasynuclein peptides are a major component of amyloid plaques in the brains of patients with Alzheimer's disease.




Figure 1. SDS-PAGE gel image. The purity of Alpha-synuclein, PLK2phosphorylated was determined to be >90% by densitometry. Observed MW ~19 kDa. Calculated MW ~18 kDa.




Figure 2. Western Blot analysis of Alpha-synuclein phosphorylation by PLK2 kinase.
